





# **Trustee Meeting Minutes March 8, 2012**

MEETING CALLED TO ORDER: 7:08 by Ray Calogero MEETING ADJOURNED: 9:40 by Ray Calogero

Trustees Present: Ray Calogero, Keith Beaudoin, Jeff Dowd, Rich L'Altrelli, Phil Schiff, Andy Egan

Trustee Absent: BJ Caraccioli

For a full review of the minutes, please come down to the office.

Ray Calogero began the meeting and his first topic was the Grant. He informed the board that applications for the scholarship are still being accepted so there is nothing to report yet at this time. The deadline is April 16th. He went on to discuss the Lake Forest Nursery School. He let the board know that the school will be making arrangements to weed through their items to make more storage room in the big closet. After a few meetings between LFYC and the LFNS board members, there will be a utilities assessment in addition to their rent as per their contract. An amount has been determined. An inspection done by the Bureau of Fire Prevention for the LFNS has failed due to the stove in the clubhouse. The hood system has been determined to be insufficient and therefore may need to be replaced with a suppression system. Many discussions are taking place between LFNS, LFYC, The Fire Prevention Bureau and the Township Building Dept. The board would like to assess the school for part of the cost for this system. The board's concern is whether or not this gets resolved before the contract is up. Andy made a motion to the extent that if LFYC is required to incur expenses or obligations related to the school because the school occupies the building then any and all expenses will be incurred solely by the school. Jeff seconded the motion. Ray, Rich and Keith were in favor. Phil was not in favor. Ray talked about social and stated hat he & Phil will be meeting with Frank Gutowski to discuss Social and that Phil will present at his turn.

Bj could not attend the meeting but did let the board know that he is reaching out to Al Rossy to discuss a starting date for the season and confirm the details for security this year. The last of the security cameras have been placed and just the wiring needs to be done. This will be done shortly. Next on the agenda was the office. The board decided that the office did not have enough work for 2 people and therefore wanted to consolidate the positions. Jennifer Whritnour is no longer employed through the LFYC and the position has been filled by Diane Hyland. Jeff spoke for BJ and gave his congratulations to Diane.

Jeff followed Bj to give his report on financials. Discussion ensued on a few areas of the club their budget numbers, where we are at and how we proceed going forward.

Next to speak was Keith Beaudoin about maintenance & docks. Some work needs to be done on the docks from normal annual maintenance to damage from the hurricane last year. Our new maintenance contractor will be taking care of these tasks. Andy will talk more about Communications when he presents his reports. As for maintenance of the club, the board decided on keeping the landscaper on for another year. There will be other repairs in the parking lot due to hurricane damage. Discussion ensued as to the importance of the jobs to be

As it was now Phil's turn to speak, he began with the Social Committee. Phil stated that one of the goals is to find more members for the committee. He and Ray have a meeting scheduled this month with Frank to go over several topics of concern. Applications for lifeguarding this summer are being received in the office. They have been reviewed by Phil and interviews will be arranged shortly. Discussion on the beach rules, procedures, job descriptions/duties will be discussed with all hired employees before the start of the season. These are currently being worked on. Discussion ensued

regarding the galley and it's maintenance and concession stand.

We've now come to Rich who will present any legal and insurance matters to the board. Insurance policies are in the process of renewal. Coverage for Employers Practice Liability Insurance has been added to the Directors and Officers Liability Policy. Rich is currently working on finishing up both the LFNS and the LFST contracts for the new year.

The final member to present his report was Andy. He informed the board that he is working on the structuring of the Porthole News. He will have more to report on that at the next meeting. He spoke to the LFST president and informed him that a rough draft of the contract has been designed with Andy's assistance. Andy formatted it so it is easier to read. This has been passed on to Rich for review. The boat course is set for April 28th and there are people signing up for this event.

### **NEW BUSINESS:**

A request from a member was received to consider using the grounds on off season to allow for storage of boats so that they are not kept on members property. Discussion ensued. There was also a complaint about commercial vehicles being parked on a property in the reservation. Discussion ensued. The board decided to call in the complaint about parking commercial vehicles.
