Lake Forest Facilities Update by Frank Gutowski

Looking at the level of the lake, we certainly need plenty of rain to get the water level up to its early season level. I know this has affected the amount of boating in April and hopefully the rain will come and help us have a great boating season this summer. Here is an update on our club:

Semi Annual Meeting, Friday May 5th at 8 PM

Our semi-annual meeting is coming up on May 5th, and we hope to have another large turnout, as we had for the annual meeting last December. In this Porthole, as well as our website, there is a copy of the agenda for this important meeting. Please join us so you may be well informed on club activities and have your opinion heard. We need to achieve a quorum by 8:15 PM that evening and will have free child

care for member's children in the Commodore Room.

2006 Dock Rentals: Sold Out

All dock slips have been rented. The final count was sixty-one member rentals and fifteen non-member rentals. More details will be provided at the semi annual meeting, May 5th.

A Dock Repair:

AAA Docks provided the needed repairs to A Dock. We had several slips with raised pilings and unstable areas on the walkway in the A1 to A-10 area. AAA has installed the support poles to reinforce the walkway and walkouts to the affected dock slips.

Office Lighting Improvements/Electrical Repairs:

Now that we have evening office hours, we have made some lighting improvements to

the front office area which will better illuminate that area. We installed a new overhead light which brightly illuminates the front entrance and also gives us illumination at night for the side bulletin board.

We also addressed concerns from the Nursery School regarding electrical outlets that continually go out and have on occasion emitted sparks. It was determined that the standard and GFI outlets were old and it would be in our best interest to replace them. We replaced all the electrical outlets and wall switches to assure proper and safe performance.

I would like to recognize our member, **Tony Maciorski**, a licensed electrician who has provided our club with the expertise in addressing these electrical issues. Thank you,

Beach Galley Overhang Repair

Repair of the beach galley overhang will be completed by the opening day picnic. We have already contracted out for the repair to be completed in May.

New Beach Badges, Parking Permit Validation Stickers and Key Cards

The 2006 Beach Badges are in along with the 2006 season parking stickers which should be applied to the parking permit hang tags we issued last year. ramp and B and C Docks.

Fence for Softball Field:

One of our objectives this year is to find a way to prevent vehicles driving across the softball field. We have decided to go forward with a telephone post and chain fence around the field. Once installed, the fence will look like the fencing we currently have on the office side of Yacht Club Drive. We have a source for the telephone poles which we are having cut into 8' sections. We hope to have the poles planted by early summer and are currently searching for the chain to attach the poles.

We would like to hear from anyone in our community that could assist us with installing the poles. We'd need a commercial grade hole digger to accommodate a telephone pole or a pile driver to plant the poles 3' into the ground. We also are searching for anchor chain, similar to what we currently use, to link the poles. If anyone has a contact for this type of chain, please contact any board member.

Canoe Rack

The Canoe Rack is ready for members who would like to store their canoe or kayak for the 2006 season. The 2006 season will run from April 1st to November 1st, at which time all canoes and kayaks will need to be removed. Our canoe rack can accommodate a total of 18 member canoes / kayaks, and the slips are available free of charge to any

member on a first come first serve basis. If you plan on placing your canoe or kayak on the rack, please call the office with your name and the rack number you selected so that we may have a record of ownership. We recommend all members use a cable or chain to lock their canoe or kayak to the rack.

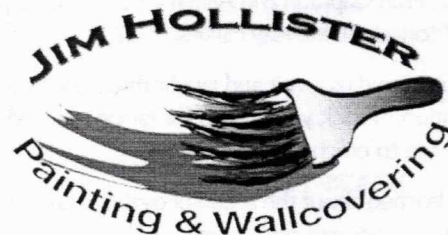

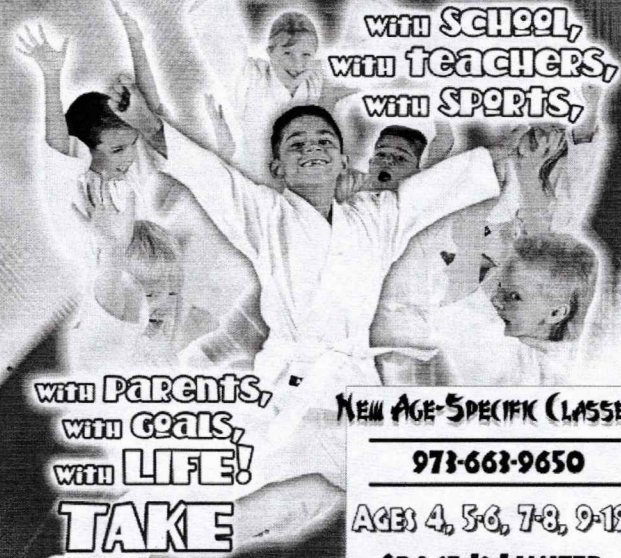

Lake Forest Nursery School



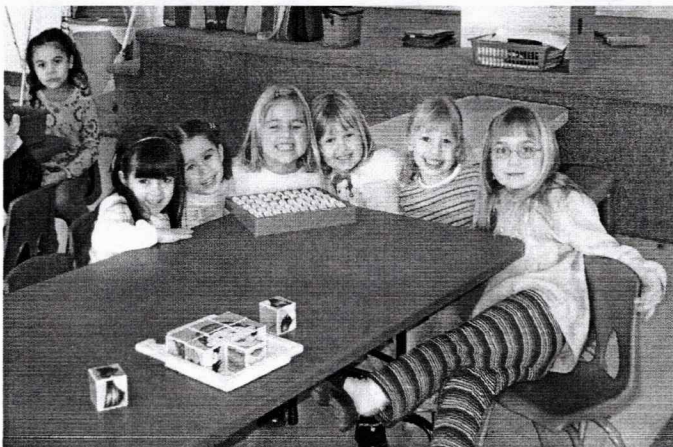

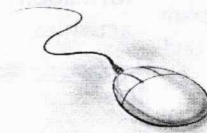

In our March 2006 Issue, we ran really cool, old water ski photos and asked for help in determining the story behind the pictures. Thanks so much to Jim McGraw (resident) and Jim Leach (former resident and our Town Administrator) for taking the time to give some history on the LFYC Water Ski Club, as well as leads for future Legacy features. Here's what we learned:

The Lake Forest Water Ski Club was founded in the late 1950's by Chester Smith and Richard Quelch. A very popular and very active group, (many of whom are list in the "Cast" below) who although did not compete, they performed one or two shows a season for the Lake Forest Yacht Club as well as the Lake Hopatcong Yacht Club. As detailed in programs like the one pictured, they performed many acts...this one listing 17! Shows had costumes, music, small kids, pyramids, clowns...a full scale entertainment production.

Starting with a ramp they brought to Lake Hopatcong from Lake Telemark, they eventually worked together to construct their own ramp as below, stationed out in the waters in front of club. In existence for approximately 10 years, they received much newspaper press and accolades for their efforts. As the lake traffic grew heavy due to increasing population, scheduling practices and events became very difficult and eventually the group disbanded.

Returning for the 2006 Season, here's a look at our awesome coaches!

Kyle Silbernagel (3rd Season Coaching)



Kyle swam on the Lake Forest Swim Team for nine seasons up until his graduation in 2004. He was a two-time captain of the team, the assistant coach of the team his senior year, and has broken numerous team and NJRLL records. Kyle swam for 11 years on many club and YMCA teams in New Jersey and Michigan, and was a four-year Varsity member, two-year captain, and a nine-time record breaker of the Jefferson Township High School Swim Team.

Recently completing his sophomore year at Fordham University, Kyle is pursuing a career in medicine with a double major in General Science and Mathematics. He is a two-time Varsity athlete for Fordham University Swim Team and has been a two-time member of Fordham's prestigious Atlantic-10 Championship team. He is also a two-time relay member finalist at the Atlantic-10 Championships.

Kyle will be in his second season as head coach of the Lake Forest Swim Team. He has also been a lifeguard at the Lake Forest Yacht Club since 2001. Kyle has been teaching swim lessons for (8) years at the area's YMCAs and has been giving private lessons for (5) years in his backyard pool. Chris Murarik (2nd season coaching)

Chris, a resident of Lake Forest, joined the Lake Forest swim team when he was seven years old. He swam on the team until he was fifteen. In high school, Chris swam for Jefferson all four years and was a team captain during his junior and senior year. As a freshman Chris received the award of Most Improved Swimmer. In his sophomore year, he was awarded the Sportsmanship Award. As a junior, he was awarded the Coaches' Award and then in his senior year, he once again won the Sportsmanship Award.

Chris's love for the sport continued on after graduation. During the summer of 2004 Chris was an assistant coach for Brian Palumbo's swim clinic at Lake Forest as well as filling the position of assistant coach for the Shongum Lake Swim team. The next winter season Chris became an assistant coach at Jefferson Township High School. In 2005 Chris came to the Lake Forest Swim team as the assistant coach and once again worked with Brian Palumbo's swim clinic. Chris's winter season brought him back to the high school to work with them as the team's assistant coach.
