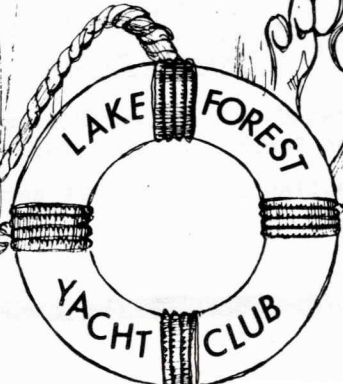

Commodore's Message

Dear Members,

This month the LFYC Board of Trustees looked primarily at the financial health of the club. The club is robust and healthy. Peter Garland has once again given invaluable support as he continues to advise the Board of Trustees and has compiled the fiscal 1986 budget.

Mr. Garland is also on the Finance Sub-Committee of the Multi-Year Planning Committee and he, along with other sub-committee members, are ready to launch their financing program. In order to keep the costs of the Club's renovation program at a minimum the committee and the Club's attorney set up a registered debenture note offering which will pay interest at an annual rate of 2% of the local one year CD rate on minimum \$1,000.-- notes. For example, a hypothetical note issued October 3, 1985 would pay 9.7% interest-- a rate 2% above the 7.7% average of the following local banking institutions:

Lakeland Savings Bank	8%
Morris County Savings Bank	7.6%
United Jersey Bank/Northwest	7.5%

More information is available in the centerfold flyer of this issue of the Porthole and from the Trustees and committee members. Don't miss this opportunity to cash in on a super deal and support the Club to boot.

The single most important contribution every Club member can make to this project is to keep LFYC accounts up-to-date. The less the Club has to pay out in interest on debenture notes the less the number that need be sold. As it is the Finance Committee has probably shaved years off the 10 years we must pay the \$143.-- annual assessment with their innovative debenture note sale (as opposed to the high rates and stiff terms of a construction loan from a banking institution). Investing in the Club's debenture note sale and paying Club bills on time will benefit each and every Club member.

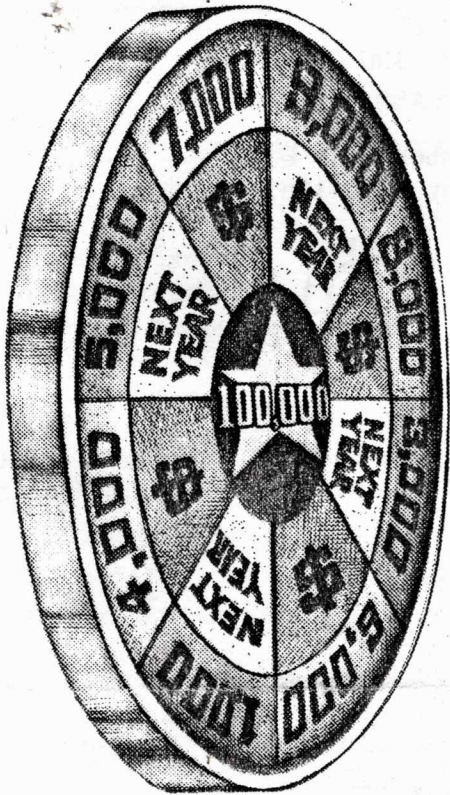


