LFYC TRUSTEES MEETING MINUTES

January 14, 1991

(Minutes are synopsisized, For a complete copy, please see Margaret at the LFYC office.)

Beach Beach rules were revised by Paul Murray and presented to Trustees. New rules will be distributed with badges, as in past. A proposal to set up LFYC as a Red Cross Waterfront was received from Marilyn Agresto (LFST coach). A committee will meet with her & report back to Trustees.

Fire Alarm System Nursery School has run into problem with the telephone company regarding cost to install 2 lines for hook-up of new system. LFNS requested Club help defray installation cost. Trustees suggested LFNS request explanation of higher costs from system installer and suggestions to make costs more reasonable.

Regatta Peter Garland informed Trustees Ed Ross has insurance "on line". Marine Police will be contacted for permit after change-over of command. Committee has met with couple of prospective sponsors. More information was requested about Club involvement, i.e. committees & numbers of people needed to run concessions.

Five Year Plan (Special Assessment) The Trustees will be contacting local contractors and soliciting prices and designs for outside restrooms. Wayne Cornelius will be contacted regarding replacement of Clubhouse windows. Margaret will send out letters to past Five Year Plan members inviting them to become involved in new committee. Ron Sorensen and Peter Garland will take those calls.

Resignation Trustee Greg Plifka submitted his resignation effective 1/14/ 92. He has purchased a home in Sparta and will be moving out of Lake Forest. His replacement will be considered by the remaining Trustees. Virginia Conk will assume the duties of Treasurer.

FEE SCHEDULE — LAKE FOREST YACHT CLUB

(effective 1/1/92)

ANNUAL DUES	Two adults voting.....	\$220.
	Single household voting.....	164.
	Tenant—two adults non-voting.....	300.
	Tenant — one adult non-voting.....	244.

Payment of dues upon joining is pro-rated by the month. Dues billing is October to September.

GUEST BADGES Guest badges are \$1. each before April 30. \$1.50 After April 30. Guest badges are available to members each year, with a limit of 6 per member household.

SPECIAL ASSESSMENT All members.....\$143.

The payment of Special Assessment upon joining the Club is pro-rated as follows: Members joining before October 1 pay \$143. Special Assessment is pro-rated monthly.

BOND All new members.....\$400.

A bond of \$400. must be purchased by all new members with the exception of tenants. Bond may be paid in one payment or spread over 5 years at \$80. per year plus \$12./year service charge (total \$92./year). Bond payments are due on the anniversary date of joining the Club.

DOCKS Docks are available on a first come - first served basis to members in good standing. Members who have had dock space in the previous year have priority and may retain their assigned dock with prompt payment of fees. A waiting list is maintained for first time dock applications and dock space change requests. Docks may be rented by member sponsored non-member, non-residents. Members should contact the office for details.

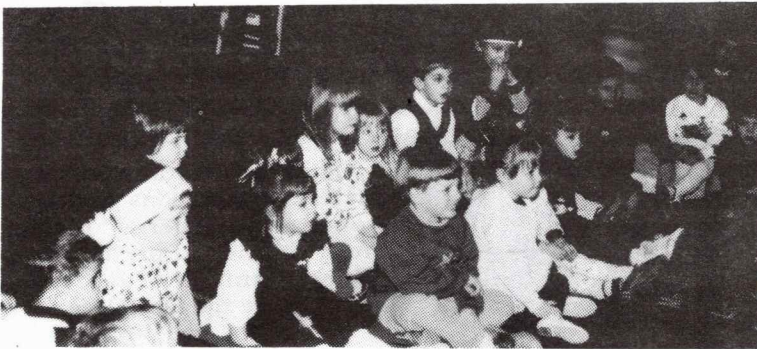

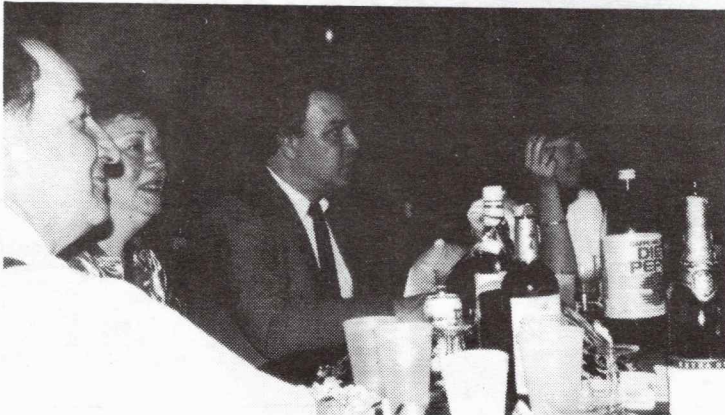

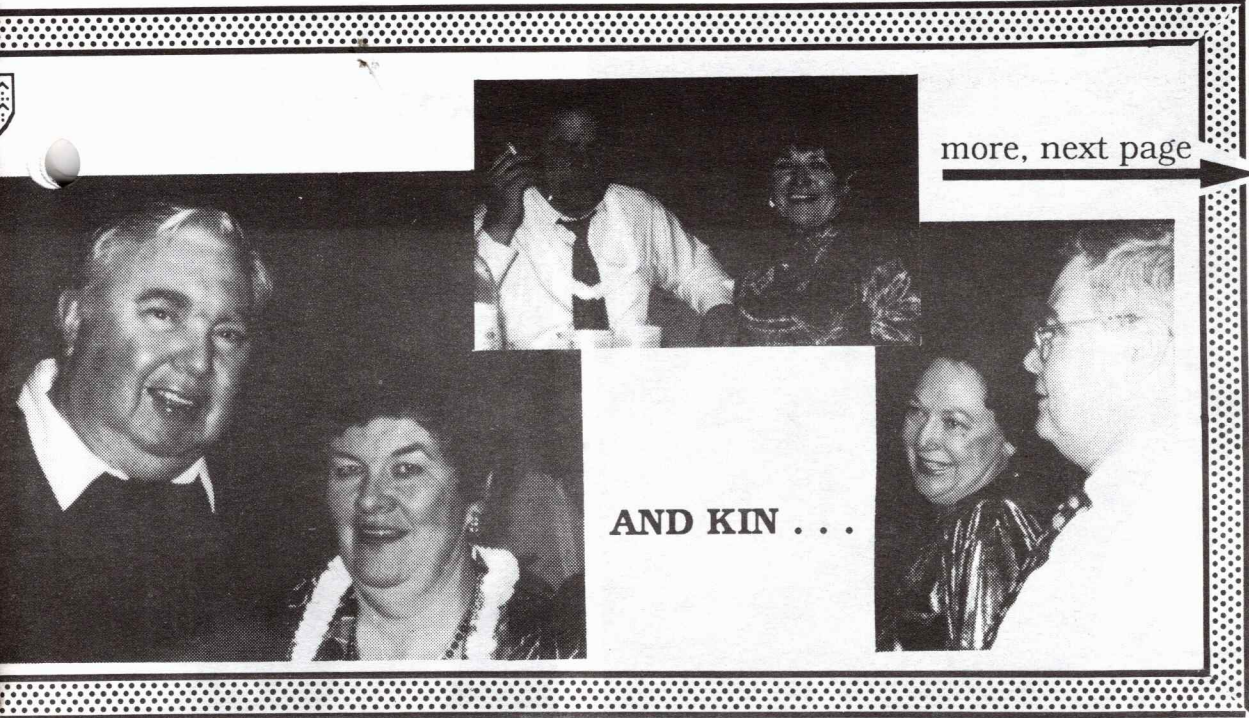

LFYC Dock Lease PROCEDURES & CONDITIONS

- Only LFYC members in good standing will be considered for dock leasing.
- A boat for which dock space is rented must be registered to the name of the member renting the space.
- No boats may be docked until the Lease Agreement has been settled. Boats docked without the Dock Master's approval may be removed at the owner's expense.
- Lessees of dock space may retain their '91 slip in '92 provided that their checks are received before Feb. 15, 1992, with the following exception: Size constraints may warrant the change of dock space. (Dock assignments & changes are at the discretion of the Dock Master.) All remaining slips will be assigned on a first come, first served basis.
- Boat must be removed from the dock space by Nov. 15, 1992 or the Club will remove it at the owner's expense. No winter storage is available.
- No boats are to be parked or stored on Club property at any time.
- Any bumper material installed by boat owners must be approved by the Dock Master. Boat owner installed bumper material must be removed by the lessee by Nov. 15, 1992.

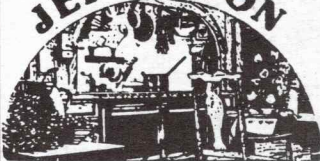
