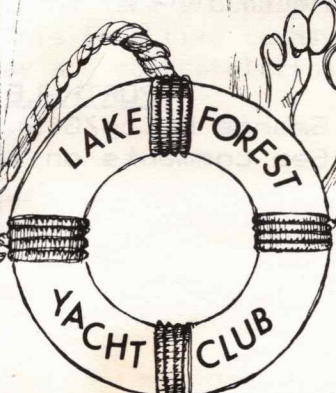
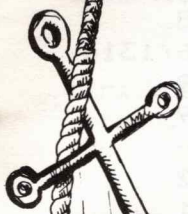

LFYC TENNIS COURT REGULATIONS

The tennis court is intended for the use of all members of the LFYC. In an effort to give access to the court to both adult and younger club members, the following rules and regulations will apply.

Time of play will be 1 (one) hour, on the hour, i.e. 8am to 9am etc.

WEEKDAYS-OPEN TIME (MON-FRI)

Weekday "open time" will be from 8am till 4pm each day. This open time is for young and adult members on a first come, first served basis. Players will give up the court at the end of each hour. Court time will be governed by the tennis clock displayed in the business office side window facing the tennis court. If no one is waiting for the court at the end of the hour, the two players may play into the next hour. extra play may occur only under these circumstances.

RESERVED TIME

Reserved time from 4pm till 8pm is for adult members only. If no reservations are made during those hours the time becomes "open time" to all members on a first come first served basis. You may reserve time by calling Margaret in the office at 0158, or Harry Moore (1493), or Vinnie Jervasi (1797), not more than 48 hours in advance. You will be given a reservation number for that date and time which will hold the court until 10 minutes past the hour. If the court is vacant 10 minutes past the hour, it becomes "open time", first come first served. The reservation name and number will be posted next to the tennis clock in the side window.

No two players may play continuously for 2 (two) reserved hours, however one player may play with a different player for two successive hours.

BADGES

WHEN ON THE COURT YOU MUST AT ALL TIMES WEAR YOUR CURRENT MEMBER BADGE. THERE WILL BE NO EXCEPTIONS TO THIS RULE, SO PLEASE ABIDE BY IT.... YOU MUST BE A MEMBER IN GOOD STANDING IN ORDER TO MAKE A RESERVATION..NO EXCEPTIONS.....

WEEKENDS PRIME TIME

Reserved prime time is from 8am till noon Sat. & Sun. If at any time from 8am till 12 noon the court is not reserved, it reverts to open time. (first come first served)

The above regulations appear to be fair and should accommodate both adult and young members.

LAKE FOREST-THEN AND NOW

It's time for part 2 of our little personal history of Lake Forest. In the original composition there are references to the person that wrote the story. I've been hiding his identity a bit just in case there is someone out there that wants to guess who penned the article and collect on that drink....here we go..

There were seven or eight homes within the development with the majority of them clustered in the initially opened area of Woodlawn Terrace and Ripplewood Drive. One existed on Yacht Club Drive and one on Crescent. We took possession of our home on Christmas Eve, 1956.

Lake Forest had a Wharton mailing address at the time and it was necessary for each family to pick up the mail at the post office on Main St. in Wharton. This inconvenience was in effect for approximately one and one half years when we were directed to install rural mail boxes. These boxes were located right on the shoulder of Route 15 directly across from the Langdon Arms, which is more readily recognized as the Pallis Three, and is currently identified as Gatwyns. The dangers of such a location did not go unnoticed, so when the number of homes increased to about 20, the boxes were relocated to the area adjacent to the Lake Forest Office. They remained there until the population increased to the extent that the postal authority rezoned in order to accomodate the present delivery system. Phone service was another problem. A pole would be erected only if four families would be serviced by it. In our case we were here six months before a four party line became available. A few years later we were allowed a two party line, and finally after three years we had a private line.

Another remembered experience is the fact that residents of LFYC were subjects (more accurately "Victims") of a diabolical sanitation "system." An independant disposal firm agreed to dispose of our garbage on a once a week schedule, providing an envelope containing .35 cents per container was placed thereunder. No checks! This system worked effectively only until the more enterprizing youth of LF (and possibly a few transient visitors) became aware of the readily available financial resource. It was not an uncommon experience to arrive home to discover that the coins were removed but the garbage remained. This necessitated a hurried trip to the then existing Sparta dump on "old" Route 15. Needless to say, everyone was pleased when garbage disposal was made part of the tax system in Jefferson Township.

That is the end of part 2. Remember if you think you know who the writer is drop the name off to Margaret. It's kind of fun to think how primitive things were in the 50s, but it also reflects simpler virtues...more innocence..except for those kids stealing the change left for the garbageman!!That is definitely what would happen today. Maybe some things were always the same, but we just don't see it that way!!

SYNOPSIS TRUSTEE MEETING MAY 5TH 1987

Margaret Dam will be taking vacation the weeks of July 19th and October 24th, 1987.

Teen Club money was given to the Club and deposited in the checking account. A decision on how to use it will be made at a later date.

The contract for service with Contex Oil will be renewed at a cost of \$89.00 per year.

Sand for the beach will be ordered through Wayne Cornelius at a cost of \$29.00 per ton, and 125 tons will be ordered.

MULTI-YEAR PLANNING

The drawing the Board saw last month is out to bid, and the financing is being looked at. Peter Gellas has instructed the Architect to come up with a simpler design. Frank Sullivan and Peter Garland suggested that the roof be repaired and a facade put up around the roof, and then address the inside of the building. The HVAC could still be placed on the roof. This would improve the looks of the building and hold down the cost. Peter Gellas will get a drawing with the facade, and go to the committees to see if it meets with their approval, then come back to the Board.

SUNSHINE

The Board approved \$200.00 per year to cover the cost of sending flowers to any member who is in the hospital. The original request was made by Betty Getchis.

NURSERY SCHOOL

The question of taking the Nursery School into the Club which was tabled last month was addressed. After due discussion it was decided to leave it the way it is, with the Club making subsidies as needed. The rent paid for 1987 of \$250.00 will be refunded, and no rent will be charged for 87/88. Motion by Phil Schiff and seconded by Susan Essig. All in favor.

COMPUTER

A report was given by Peter Gellas. After some discussion it was decided to budget \$2500.00 for the appropriate software, hardware and training for Margaret. The motion was made by Phil Schiff and seconded by Malcolm Yorkston. Sarah Corragio and Margaret will approve the software.

RECREATION

George Maguire sent a letter to the Board stating he will not return this year. A letter will be sent to George thanking him for the fine job he did in the past, and wishing him success in the future. There are two applicants for the position who will be interviewed by J. Leach, P. Gellas, S. Essig, and H. Moore. Letters will be sent to the applicants asking them to a meeting.

CLEAN-UP

Wayne Cornelius will be asked to fill in the trench which was dug by the dock area. This was done without the approval of the Board and the project should not be undertaken at this time. There is a pile of garbage at the side of the handball court which Wayne will be asked to remove. A motion was made by Phil Schiff and seconded by Peter Gellas to sod the area by the wall and put woodchips around the trees for a cost not to exceed \$2600.00. All in favor.

SIGN

Bill Leach would like to see a sign at the front gate which says both "Private Property", and "Lake Forest". The Multi-Year Planning committee asked Bill to get one designed. 3 designs were presented. Sign design #2 was chosen on a motion by Malcolm Yorkston & seconded by Tom Donnelly. Cost not to exceed \$1200.00. All in favor.

GALLEY

Marsha Morgan will not be returning this season, but P. Gellas will contact Missy Moran.

SECURITY

Bill Leach reported all was well until the guard showed him what happened recently where kids 10 to 15 years old hang out. Cigarettes burned into the walls, doors scorched, and brick work damaged. Benches have been moved, sometimes after midnight. Skate boards have become a problem. The children have damaged the walls with them & taken them onto the tennis court. Bikes have been on the court also. The surface of the court will sustain damage if this doesn't stop. The handball area has been defaced with graffiti. Should the court be locked at all times with a key available upon request? If so who keeps the key? Should the member family of a youngster be billed for damage if the child is caught? Should the membership be suspended or revoked?

There is some question if a septic could be put on our land if a pool is granted for his.

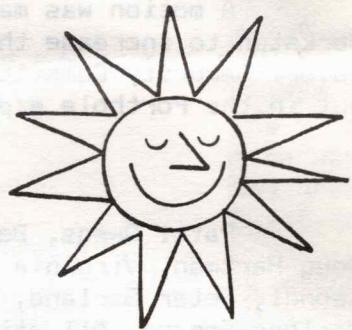

COCONUT LEMON MOUNDS

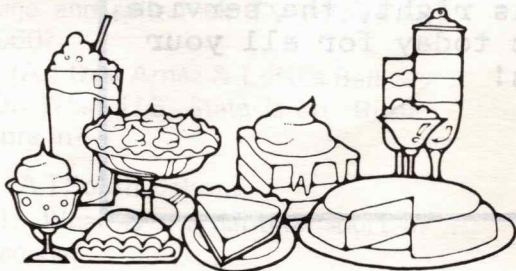
Ingredients:

2 eggs
1 cup sugar
1 tablespoon grated lemon rind
 $\frac{1}{2}$ cup sifted all-purpose flour
1 bag (7 oz.) flaked or shredded coconut

Garnish (optional): red candied cherries, halved, light corn syrup

Directions:

1. Preheat oven to slow (325°). Generously grease cookie sheets with shortening.
2. Beat eggs in small bowl until thick and fluffy. Gradually beat in sugar, beating until mixture is very thick. Fold in lemon rind, flour and coconut until flour is just incorporated.
3. Drop by heaping teaspoonfuls, 1 inch apart, onto greased cookie sheets.
4. Bake in preheated slow (325°) oven for 18 to 20 minutes or until golden brown. Remove cookies immediately from cookie sheets to wire rack to cool.
5. To prepare optional garnish, top each cookie with half a candied cherry. Brush with corn syrup while still warm. Let cool completely.



APPLE CRISP

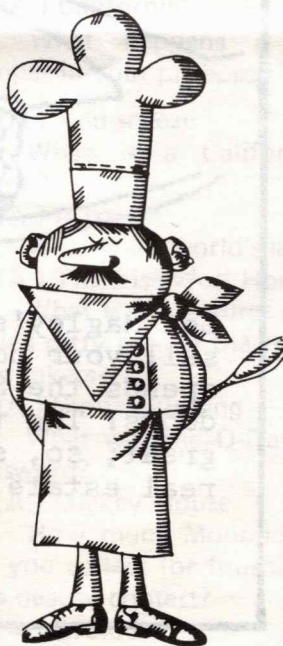
Ingredients:

6 large apples, sliced and peeled
 $\frac{1}{2}$ cup water
2 teaspoons cinnamon
 $\frac{1}{2}$ cup butter or margarine, melted
 $\frac{3}{4}$ cup sugar
 $\frac{3}{4}$ cup flour

Directions:

Place sliced apples in a shallow buttered baking dish. Pour water over apples and sprinkle with cinnamon. Mix melted butter, sugar and flour until crumbly. Spread over apple mixture.

Bake uncovered at 350° for 45 minutes.

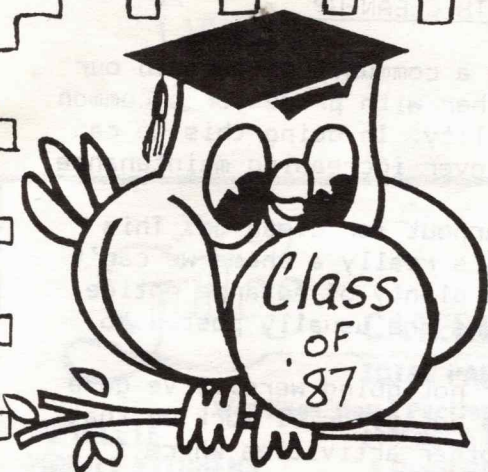

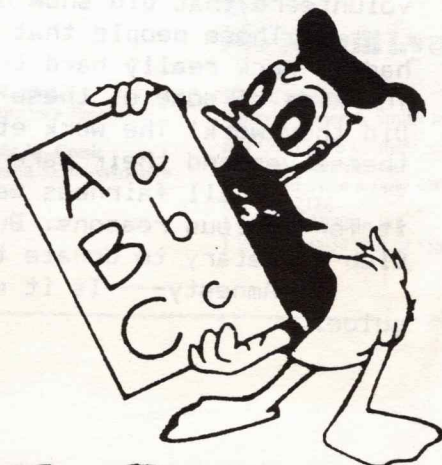

RESULTS OF THE MAY 16TH CLEAN-UP

The primary reason we look to a community effort in our Lake Forest clean-up is to join together with pride for a common interest in our Lake Forest club facility. In doing this we can hold down to an acceptable level the ever increasing maintenance costs.

Sat. May 16th we had a 13% turnout for clean-up. This community has 203 member families. It's really a shame we can't get closer to a 50% turnout. There is plenty of advance notice. It's printed in the Porthole, and signs are usually posted to catch everyones attention.

Some of the reasons given for not going were..I've gone for a few years, or, let someone else do it, or, I work on that day, or, I've got kids in sports or other activities where I need to be there, or, I really don't care, or, pay for the work..., Yes, it looks like that is the impending direction the club is taking. The \$10.00 fee which was put into effect a few years ago did have a positive effect. It got 90 people out for 1 or 2 hours to help clean up. That was the only intent. It wasn't the \$10.00. Instead, the message we got was clear, "Pay to get it done." There is the possibility of a dues increase to fund maintenance work at the Club.

Another point to consider...How can some people come down to the beach to sunbathe during clean-up hours, while the volunteers that did show up worked around them??

Those people that did show up did a heck of a job. They had to work really hard to make up for the other 87% no shows. The kids of some of these parents need to be commended also.. Did they work! The work ethic they displayed was a compliment to themselves and their parents.

In all fairness we know there are people that can't make it for various reasons. But even some of them have contacted the Club Secretary to donate their hour in the coming weeks.
