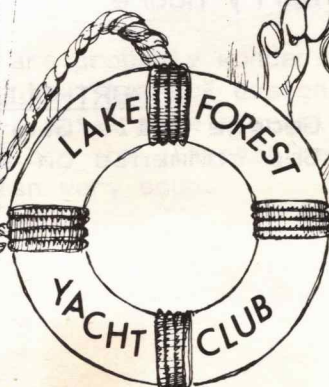

## LFYC TENNIS COURT REGULATIONS

The tennis court is intended for the use of all members of the LFYC. In an effort to give access to the court to both adult and younger club members, the following rules and regulations will apply.

Time of play will be 1 (one) hour, on the hour, i.e. 8am to 9am etc.

### WEEKDAYS-OPEN TIME (MON-FRI)

Weekday "open time" will be from 8am till 4pm each day. This open time is for young and adult members on a first come, first served basis. Players will give up the court at the end of each hour. Court time will be governed by the tennis clock displayed in the business office side window facing the tennis court. If no one is waiting for the court at the end of the hour, the two players may play into the next hour. extra play may occur only under these circumstances.

### RESERVED TIME

Reserved time from 4pm till 8pm is for adult members only. If no reservations are made during those hours the time becomes "open time" to all members on a first come first served basis. You may reserve time by calling Margaret in the office at 0158, or Harry Moore (1493), or Vinnie Jervasi (1797), not more than 48 hours in advance. You will be given a reservation number for that date and time which will hold the court until 10 minutes past the hour. If the court is vacant 10 minutes past the hour, it becomes "open time", first come first served. The reservation name and number will be posted next to the tennis clock in the side window.

No two players may play continuously for 2 (two) reserved hours, however one player may play with a different player for two successive hours.

### BADGES

WHEN ON THE COURT YOU MUST AT ALL TIMES WEAR YOUR CURRENT MEMBER BADGE. THERE WILL BE NO EXCEPTIONS TO THIS RULE, SO PLEASE ABIDE BY IT.... YOU MUST BE A MEMBER IN GOOD STANDING IN ORDER TO MAKE A RESERVATION..NO EXCEPTIONS.....

### WEEKENDS PRIME TIME

Reserved prime time is from 8am till noon Sat. & Sun. If at any time from 8am till 12 noon the court is not reserved, it reverts to open time. (first come first served)

The above regulations appear to be fair and should accommodate both adult and young members.

### THE BEGINNING

During the spring season of 1956 I became aware of the development of the Lake Forest area by way of a brochure given to me by a friend who had purchased a building lot the day before. The facility layout seemed to be too pretentious to be realized. The brochure indicated the area would eventually be comprized of a large clubhouse, swimming pool, nine hole putting green, tennis courts, and all the various recreational facilities normally associated with such an enterprise. Though somewhat skeptical, my wife and I decided to "check it out".

Route 15 was at the time a narrow two-lane traffic thoroughfare. As we left Dover and proceeded onward and upward, in a wary manner, it seemed incredulous that such a "Shangrila" could exist in so close a proximity to the highway. The entrance into Lake Forest was directly off RT 15. Some residents may not be aware that in those days Lake Forest provided a security guard. About one block in from the entrance there stood a neat little building manned by a kindly uniformed gentleman, affectionately known as "Ol Mac." If memory serves correctly, his name was Mr. MacArthur. At any rate, Mac greeted us and asked the purpose of our visit. He then called the real estate office (now the LFYC office) and informed them of our arrival. When we reached the crest of the hill on Yacht Club Drive, the lake, and surrounding scenery exploded before us. I was impressed to the extent that I said to my wife, "Honey, this is a beautiful spot, I think we're in the market." She agreed. Our sons Bill and Jim were not too thrilled with the idea of moving away from their friends, but thought the swimming facility was "keen". The facilities at that time consisted of a snack bar with a paved patio, rest rooms, a tiny change room, the diving platform, and a not too sandy beach. That was it!!!!

That was part 1. In an effort not to use too much space in the Porthole, I will break this charming story into 4 or 5 parts. Follow along with us as we recount about 30 years of history here on the lake. Maybe in it's small way it will make us think about how we would like to be again, and make all of us realize just how lucky we are to live here.

Phil Schiff made a motion to eliminate the \$10.00 maintenance fee for 1987. Malcolm Yorkston seconded. 5 in favor, 1 opposed. Harry Moore not present.

SECURITY

Peter Gellas reported that Charles Vandermark would like to work directly for the club. Mr. Vandermark is presently employed by the guard service. Peter said he is the guard we've had in the past. 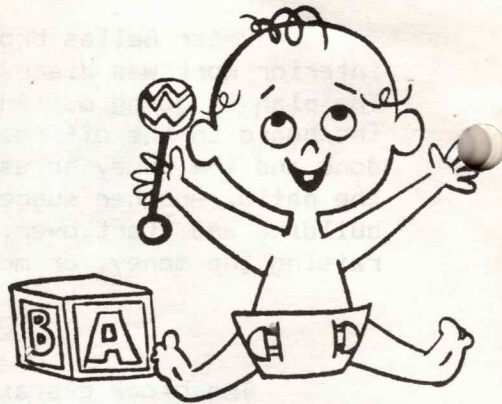

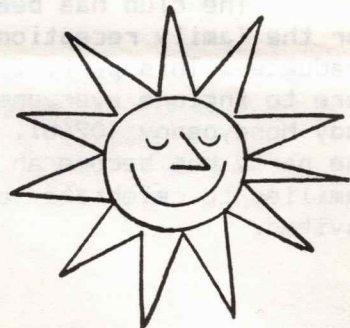

## PEPPER STEAK

- 1½ lbs. sirloin steak, 1/6" thick
- 1½ teaspoon salt
- 2 medium onions, chopped  
(about 1 cup)
- 1 cup beef broth
- 3 teaspoons soy sauce
- 1 clove garlic, minced
- 2 green peppers, cut into 1" pieces
- 2 tablespoons corn starch
- ¼ cup cold water
- 2 tomatoes, peeled and cut into  
eighths
- 3 to 4 cups hot, cooked rice.

Trim fat and bone from meat. Cut meat into 4 to 6 serving pieces. Grease large skillet lightly with fat trimmed from meat. Brown meat thoroughly on one side. Turn and season with remaining ¼ teaspoon of salt. Push meat to one side. Add onions, cook and stir until tender. Stir in broth, soy sauce and garlic. Cover and simmer 10 minutes or until meat is tender. Add green peppers, cover and simmer 5 minutes more. Blend corn starch and water. Stir gradually into meat mixture. Cook stirring constantly, until mixture thickens and boils. Boil and stir 1 minute. Add tomatoes, heat through.

Serve over rice. Makes 4 to 6 servings.

## STUFFED ACORN SQUASH

- 2 acorn squash, halved and seeds  
removed
- 1 lb. ground sausage meat
- 2 teaspoons brown sugar

Sprinkle ½ teaspoon brown sugar on each half. Stuff with sausage. Put in pan with enough water to cover the bottom of the pan. Cover with foil. Bake in oven at 350° until squash is soft and tender—about 40 minutes.

Serves four.

## DATE AND NUT BREAD

- ¾ cup chopped nuts
- 1 cup chopped dates
- 1½ teaspoon baking soda
- ½ teaspoon salt
- ¼ cup shortening
- ¾ cup boiling water
- 2 eggs
- ½ teaspoon vanilla
- 1 cup sugar
- 1½ cups sifted all purpose flour

Combine nuts, dates, soda and salt in a mixing bowl. Add shortening and boiling water. Allow the mixture to stand 15 minutes. Stir to blend. Beat eggs slightly and add the vanilla. Stir in the sugar and the sifted flour. Add to the date mixture. Do not over mix. Place in a greased 9x5x3" loaf pan. Bake one hour in a 350° oven. Spread with cream cheese when serving.

NEW BOATING REGS-MAY 1ST, 1987

The following is an overview of the new boat regulations going into effect May 1st, 1987. This is for the convenience of our boating enthusiasts. If more information is needed contact the "LAKE HOPATCONG PROTECTIVE ASSOC.", PO BOX 443, LAKE HOPATCONG, NJ 07849.

1. Effective May 1st there will be a daytime speed limit of 30 miles per hour. In addition, the night time speed limit will be reduced from the present 15 miles per hour to 10 miles per hour. Also all vessels within 100 feet of shore must maintain a speed of 5 miles per hour or less.

2. It will be presumed careless operations if the entire hull of a boat leaves the water. If water levels exceed 6 inches from the top of the dam at the State Park, the marine police are authorized to impose slow speed and wake regulations.

3. All vessels will be required to carry a standard signal flag to indicate that it is towing a skier. On weekends the maximum # of skiers permitted behind one boat will be 2. Further, 4 areas of the lake (Byram Cove, Woodport Cove, and the area between Halsey Island and Raccoon Island and Prospect Point will be closed to skiing on weekends from 11:00am to 5:00pm, from May 15th to September 15th.
