TO MEMBERS, LAKE FOREST YACHT CLUB

Dock space is available for rent in 1995. Dockmaster is Peter Garland (-1661). For those interested, please note the following procedures and conditions.

1. Only members in good standing have the right to rent dock space. All financial obligations to the Club must be paid up-to-date before dock space will be assigned.
2. Only boats registered in the name of active members are eligible for mooring.
3. In fairness to all members, no boats may be docked until your lease has been settled. **PLEASE RESPECT THIS RULE AND CONFORM TO IT.** Boats docked without proper identification may be removed at the discretion of the Dockmaster at the owners expense.
4. Lessees of slips may retain their 1994 slip in 1995 provided that lessees checks are received before Feb. 15, 1995. **NO GRACE PERIOD WILL BE EXTENDED.** Otherwise all slips will be assigned on a first come, first served basis. Also, size constraints may prevail. Both rules will be strictly enforced.
5. No winter storage will be permitted. Boats must be removed by Nov. 15, 1995 or the Club will remove it at the owner's expense.
6. No boats are to left on the grounds.
7. Dock lease rates:

A Dock Slips.....	\$245.
B Dock Slips	210.
C Dock Outside Slips	245.
C Dock Inside Slips	210.
8. There will be a \$5.00 per diem charge for unauthorized use of the docks.
9. Carpeting is discouraged, and if applied to dock must be removed by Nov. 15, 1995.
10. If you are NOT renewing your slip, please notify Peter Garland (-1661). You may reserve your slip by returning the accompanying form, together with a check for full payment of your dock lease to the LFYC office no later than Feb. 15, 1995.
11. **DO NOT REMIT TO DOCK MASTER.**
12. **NO GRACE PERIOD WILL BE EXTENDED.**
13. You will receive confirmation of your dock lease on or about March 15, 1995.

GROUND/MAINT Tree has fallen from Abdy property on A catwalk, Abdy has been notified by letter. One Ice Eater being returned for repair. Snow plowing contract goes to W. Cornelius. Basketball court light has been vandalized. Manny Fanarjian has offered to take care of getting annual photo collages reframed after vandalism damage of Feb. '94. Proposed setting of add'l RR ties around septic field so boat launchers don't park on it.

CLUBHOUSE New chairs delivered, 91 of old ones will be offered to members @\$1.

SECURITY Surveillance cameras suggested to curb vandalism plaguing Club property: in Dec. office broken into & 2 phones stolen; then electric meter stolen; plus others.

We are asking every member for help in protecting our Club. Stop by the Club and look around. As you pass by take a moment to note who is on the premises. If you see anything suspicious please report it to any Trustee or call the police directly. And parents, please speak to your children.
