

### Lake Forest Facilities Update by Frank Gutowski

We continue to have limited activities at the club during the winter months. Here is an update on our club facilities:

#### **Clubhouse Roof Leak**

Due to the high winds and rain we received on Tuesday, January 17th, we discovered several roof leaks at the clubhouse. Due to the leaks, the Nursery School cancelled classes on Wednesday and Thursday of that week as we addressed the damage. Jeff Phillips, LFYC member who is an expert in roof repair, assessed that the damage was due to severe cracks in the roof shingles and made the necessary repairs. He also advised us that the roof will likely leak again if additional repairs or roof replacement is not addressed. With this development, the board will now need to consider this issue and plan the appropriate action.

#### **LFYC Office Manager**

In early January, our office manager Susan Bilyk, notified us of her resignation effective lanuary 28th. We'd like to thank her for her time with us and offer her best wishes in her new endeavor. We immediately initiated a search for her replacement including an advertisement in the AIM action news. The search is for a qualified individual who has experience in running an office and has a proficiency in QuickBooks accounting software. If we do not have a new office manager in place by January 28th, the office hours will be suspended, with internal office operations provided temporarily by the Trustees. If needed, notification of suspended office hours will be in the glass encased bulletin board at the club office.

#### **Parking Permit Tags**

Even though we are in the offseason, please remember that you must display your parking permit whenever parking at the club facility. We have signs posted that our facility is for members only and all vehicles must have a parking permit. Last winter we had many nonresidents park in our lot to go onto the ice for ice fishing and other activities. We gave out warnings and had the police issue summonses to repeat violators. This year we will not be issuing any warnings. We will have the police ticket vehicles without permit tags. So, please remember to display

your parking tag whenever parking on our club property.

#### Lake Forest Website

We have made progress on launching our new website. Our new Trustee, Pat Brennan, has provided us with valuable assistance in securing our domain name and given us insight on the particulars of website development. One recommendation Pat had was to switch from a .com to .org domain name which would be better suited for our organization. So we have secured the .org domain name which will be www.lfyc.org . We have a new member in our community who has offered to help us design and manage the website so we expect to have it up very


#### Club Security/ Surveillance Cameras

Due to vandalism on our softball field and the theft of a kayak last year, I researched the possibility of enhancing our security surveillance at the club. The improvements were to include clearer surveillance at A. B and C docks, the canoe rack and surveillance of the softball field. I had a Lake Forest resident, lack Frucci of Lakeland Security, come in and evaluate the system and provide recommendations and a proposal. It was determined that to meet the objective, we would need to replace the current cameras, add three additional cameras and install a digital video recorder.

The project was discussed at the January Trustee meeting and it was decided not to allocate funds toward the project at this time. This decision was also based on the Capex survey responses we received from members which rated it seventh on the list of projects members want us to pursue. So we will shelve this surveillance project for now and work on trying to improve our current system's functionality.





## **Capital Expenditure Survey Results**

Surveys were sent to the LFYC membership on (2) occasions asking for input on various capital projects that the board is considering. In total, there were 38 responses. The list below shows the order of priority that the responses indicated.

#### **IMPROVEMENTS:**

- 1. Replace propane heating system with new oil system
- 2. Repair or replace Galley overhang
- 3. Renovate club house bathrooms
- 4. Renovate club house ceiling walls & floor
- 5. "A" dock repair
- 6. "A" dock replacement
- 7. Surveillance cameras
- 8. Post & chain fence around ball field
- 9. Post & rail geese fence at Stanley Point
- 10. Tennis court lights
- II. Renovate ball field with striping and bases
- 12. Thicker tree line around tennis courts to block wind

Based on the survey results and projected cost, the projects that the board has voted to pursue are:

- Replace the heating system
- Replace or repair the galley overhang
- Major repair to A Dock

Meeting called to order at rooms was number (3). To be postponed until 2007. Discussion ensued about moving up A dock repair (survey results number (5), due to safety issues. Frank to obtain better estimate to repair or replace partial A dock.

#### Frank:

#### Porthole update

Postage rate decreased from .34 to .13 per mailing due to letter size and sorted rate. We're taking advantage of a Staples offering a 20% rebate/rewards discount due to annual commitment to be paid quarterly. The January issue had (12) advertisers; (10) returning and (2) new advertisers approached the club. One advertiser made a I-year commitment. All nonreturning advertisers were sent the latest Porthole. Discussion on rotating Trustee column. Birthday lists/ bulletin boards need content submissions.

#### Website project

Pat to procure rights to LFYC.org from Registrar. Pat to procure rights for domain LakeForestYachtClub.org. Recommendation to research DSL provider for office, eliminating Optonline costs netting a savings per month.

#### **Boat race contract**

Draft sent out to Trustees for their input, changes made. Final draft to be shared with the Trustee's later this week then sent to the Association for their review.

#### Other

Frank, presented the Trustees with a signed one year service agreement that covers off season trash removal, snow removal and clubhouse cleaning service. Contract

signed with Buddy Coutts. Presented option to spray fields with spray to deter geese. Sprayed once per month, 5 gal concentrate makes 500 gallons at \$350 and covers 100,000 sq ft. Agreed to try Goose Stopper spray, if proven successfully we will continue coverage.

#### Pete:

#### Insurance

Peter filed claim for theft recently discovered with our bond holder, the expectation is that the claim will be covered. Our bonded policy covers us for \$100,000. This policy was unknown to the board at the time of the annual meeting.

#### **Other**

Expressed an interest to assist all Trustees' in their duties on an as needed basis.

#### Fred:

#### Commodore's discussion to trustees

Fred asked that each Trustee selfevaluate their performance on the board and progress on their personal tasks taken on in behalf of the club and if they feel they are not meeting up to the obligation that they first ask for help from their fellow trustees, and in the worst case decide to step down from the board. Please ensure that any commitments made by each board member be fulfilled prior to committing to additional tasks.

#### Other

Fred distributed Lake Forest Yacht Club By-Laws, prior to the changes voted in during the last annual meeting.

Club member expressed some concern about the babysitting provided during the annual / semi-

annual meeting and the cost associated with it. Fred made mention to charge \$5/3/2 per child to baby sit, concessions can be made for hardship. Frank made mention to ask the life guards to perform babysitting duties for their regular wage. Chuck, felt club should pay. Fred made motion to offer free babysitting at the annual semiannual meeting and for the club to pay up to 2 persons \$10/hour for said babysitting. This in an attempt to stimulate better attendance at. our annual and semi-annual meetings. Chuck seconded. Unanimous approval. Notice to go out in Porthole prior to meeting.

## 2006 Season Dock Rental Information

The club office has mailed out boat. All of the above criteria the 2006 dock slip rental invoices and rental agreements to all members who rented dock slips in 2005. The 2006 dock rental fee for members is \$410. If you plan on renewing for the upcoming season, please return the completed and signed rental agreement along with a copy of your boat registration and payment by March 15<sup>th</sup> 2006. Also, please indicate if there is any repair issue that you feel needs to be tended to regarding you slip.

If you have no intention to renew your dock slip for the 2006 season, please contact Frank Gutowski so that he may reassign the slip to another member. We already have several members requesting available dock slips this season.

Since we only have seventy-six dock slips, we will limit dock rentals to one slip per member family until March 18th to accommodate as many members as possible. As is club policy, dock slips will only be rented to members whose: financial obligations to the club are current, have completed a signed rental agreement and provide a copy of the boat registration indicating member ownership of the will be required before LFYC approval of dock slip rental or

For new members or members renting for the first time, we will have at least twelve open dock slips for the 2006 season. If you'd like to rent a dock slip for the 2006 season please contact the club office at 663-0158 to request a dock rental agreement. The open dock slips will be reserved on a first come first served basis for members who meet the above rental criteria. Actual slip assignments for new renters will be determined starting March 16th, after member dock renewals are confirmed.

Members who would like to rent a second dock slip may do so after March 18th. On April Ist, all remaining open dock slips will be made available to non-members at a rental fee of \$1,000.


