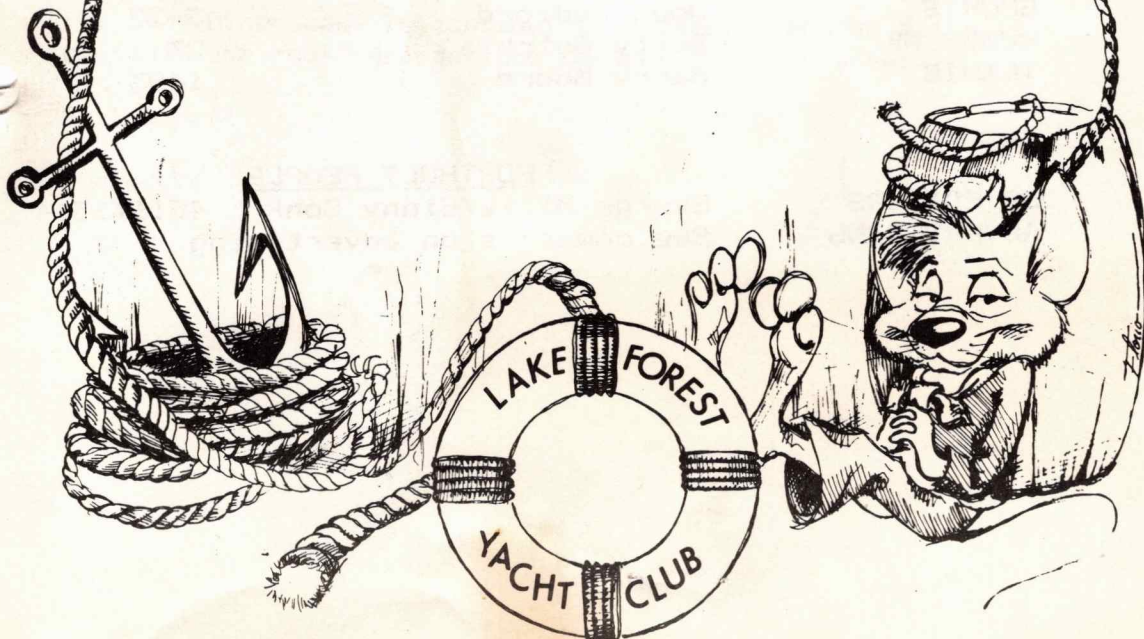

Dear Members,

July 1987

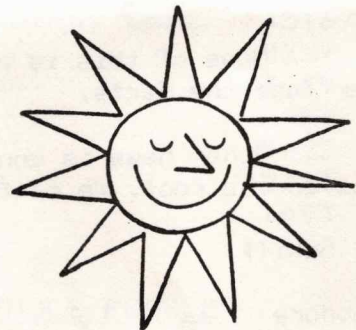

ATTENTION BOATERS

WAITING LIST:

The old annual first come, first serve, system of dock assignments has been replaced with a "permanent waiting list". Renewals by April 15th will still enjoy retention of their slips. Newly vacant slips will be assigned in sequential order from the "Waiting List".

Anyone who wants a slip or a larger slip or wants to move to a different slip for any reason should put their name on the list and indicate what is wanted. As openings occur they will be assigned.

It is hoped that this system will eliminate some of the inequities of the old system while preserving the rights of those already renting slips.

NEW BOATING RULES:

The New Jersey E.P.A. has published new (additional) rules for boaters on Lake Hopatcong.

In capsule form they are:

- (1) Ski (defined as anything with a rider being towed) lines between 50 and 75 feet.
- (2) Tow boats must have an operator and observer over 13 years of age.
- (3) No skiing 5/15 - 9/15 on Saturdays, Sundays and Holidays between 11:00 a.m. - 5:00 p.m. in Byram Cover,, between Raccoon Island and Prospect Point, between Prospect Point and Halsey Island nor in Woodport Cove (defined as north of Brady Bridge).
- (4) No skiing within 100 feet of shore, any structure, buoy, swimmer, or vessel.
- (5) Ski tow boat must display an orange triangular 12" x 12" x 12" flag 4 feet above the highest part of the boat.
- (6) No dropping of skis.
- (7) Sunset to sunrise speed limit of 10 mph.
- (8) Weekend and holiday daytime speed limit of 30 mph 5/15 - 9/15.

(9) 5 Mph speed limit within 100 feet of shore, pier, bridge, buoy, or swimmer.

It might be noted that these new rules are to be enforced by only two patrol boats, no rules are given to license holders and the only requirement for getting a license is age and \$3.00; no test, no education, no brains.

TRUSTEE MEETING SYNOPSIS

DOCKS

Doug Hartmann said a waiting list will be established for future dock space, or the changing of dock space due to buying a new boat of a different size. The list will be kept by Doug and Margaret.

MAINTENANCE FEE

Jane Leach stated it was a mistake to take away the \$10.00 fee. Everyone should pay for outside cleanup by a contractor.

DUES

The dues structure should be reviewed by the finance committee and a report made to the board.

OFFICE

Margaret Dam was given a raise starting with the next pay week. All in favor.

SALE OF THE PROPERTY

The Judge ruled in favor of the Club. Marlene Genaud was in attendance. Ann Huber will contact the insurance company to have the title insured without the restrictions. There is a 45 day time limit for an appeal. A letter will be sent to Marlene thanking her for all her time and effort.

PLAY/DANCE

Rehersal will be June 10th. A sign will be put up advertising the dance. Penny Liker will get the phone tree involved.

LIFEGUARDS/REC. DIRECTOR

Robert Kylish has been hired at a salary of \$8.50/hr. He will start Sat., and interview lifeguards. Donna Podens will return this year, but has requested a raise. H. Moore stated there might be a lifeguard shortage because all clubs have to have them. Bob Kylish suggested more competitive rates for the lifeguards:

1st. yr. \$4.25

2nd. yr. \$4.75

3rd. yr. 5.15

A guard with 3 yrs. experience should start at \$4.75. There will still be a .30 cent/hr adder for each certificate a guard has. It was voted to accept the sched. of Kylish, and to hire Donna with a CPR certificate. \$6.00/hr, 5.70 without CPR. Hire two new guards at \$5.00/hr. max. with Bob to interview.

M. Yorkston suggests schools be contacted to get guards that way. We still do not want to hire within L.F. Jane Leach wanted to know where the money is coming from for all the raises.

MAINTENANCE/SECURITY

An order will be placed for 6 benches to replace those damaged. Picnic tables will also be needed. Phil and B. Leach will see about the tables. The benches will cost about \$130.00 each, ordered from Totowa Concrete Products. Bill Leach will install a new timer for the dock lights. The guard will call the boat owner if he sees a problem with the boat.

CATWALK

At seasons start 4 pieces of the catwalk were missing. Three were recovered. The 4th was permanently attached to someones property. After being approached and threatened with a complaint the dock was returned as of 6/6/87.

ROOF

P. Gellas has not gotten a bid on the roof as of yet, but it may come in at \$120,000.00. If it does we may have to borrow the cash to do it. Where will the money come from to do the inside of the building? The roof has first priority. Jane said prices should be gotten, then plans and prices should go back to the committee. They may go with a membrane roof if prices are too high. Mickey stated we must go to the committee before anything is decided. P. Gellas will address the June meeting and explain that Tempex would not do it, and how the new drawing was arrived at. The Trustees must give direction as to how to improve the Club.


